### Overview

- Teacher Licensure Course (TLC) Status Report
  - Includes all Course Master (CN) Records reported to EMIS and the proper certification status of the teacher of record
  - Is generated for all EMIS reporting entities and updated nightly
  - Is used to provide data for Local Report Cards, certain state and federal funding, and for ODE program evaluation and planning
- This presentation will focus on troubleshooting the TLC Status Report, which is generated during the Initial Staff and Course (L) Collection

# Understanding TLC Status Report Data



### **TLC Status Report Data**

- Data from the following collections is used to generate the TLC Status Report
  - Initial Staff and Course (L) Collection
  - Final Calendar (C) Collection
  - Beginning of Year Student (S) Collection
  - Midyear Student (S) Collection
  - SOES Beginning of Year Student (S) Collection
  - SOES End of Year Student (S) Collection
- Report is generated nightly with data submitted by 5pm throughout the Initial Staff and Course Collection



# Course Master (CN) Record Data

- Local Classroom Code
- Location IRN
- Subject Code
- Curriculum Code
- Delivery Method
- Student Population
  - The population of students for whom the curriculum is intended and not about the students who are actually enrolled
- Educational Option



# Staff Demographic (CI) Record Data

- Staff Name
  - If reported as 9999999999 the name will appear as  $\ast$
- State Staff ID
  - Cannot be a ZID and be properly certified
- Education Level
  - Is not directly used in the certification process
  - A valid value must be reported and the highest, most correct value should be reported
  - Refer to the EMIS Manual Staff Demographic (CI) Record for valid values



# Staff Course (CU) Record Data

- Local Classroom Code
- Staff Provider IRN Element
  - The district IRN of the entity who employs the contracted staff
  - Courses reported with a Staff Provider IRN of another LEA will appear on both LEA's TLC Status Reports
- TLC IRN (HQT IRN)
  - Indicates where a course will count for accountability purposes
  - See section 4.3 Staff Course (CU) Record for reporting rules



### Data From Other Records

- Staff Employment (CK) Record Data
  - Assignment Area
  - Type of Appointment
- Student Course (GN) Record
  - Local Classroom Code
- Student Attributes Effective Date (FD) Record
  - Disability Condition
  - State Equivalent Grade Level
- Contractor Staff Employment (CJ) Record



### **Course and Calendar Dates**

• Dates are used to determine a "course calendar"

- Grade Schedule (DL) Record First and Last Day of School
- Course Master (CN) Record Course Start and End Date
- Staff Course (CU) Record Staff Course Start and End Dates
- Student Course (GN) Record Course Enrollment Start and End Date
- The "course calendar" is then used to determine
  - Students who are counted as being in the class
  - Teacher who was with the course the longest



### Multiple Teachers on a Course

Determination of the teacher who appears on the TLC Status Report is based on

- Teacher with greater amount of time teaching the course
- Multiple teachers teaching the same amount of time
  - Uses first teacher the report finds who is properly certified
  - If none are properly certified the first teacher on the course will appear

### **CORE** Database

### The TLC Status Report

- looks at each course and at data regarding the teacher's current credentials from the CORE database
- determines if the staff member is appropriately credentialed to teach the
  - subject code
  - student population
  - grade level(s) of the students scheduled in the course



### **Certification and Licensure Search**

This resource was created to assist districts in validating data that appear on the Teacher Licensure Course (TLC) Status Report generated by EMIS. For a list of the current subject codes, please see EMIS Manual Section 4.7. *This search has been updated for FY19*.

#### Search for Regular Teaching Certificates and Licenses

This search is for situations where a course master has been submitted and the student population is PR or RG (i.e., regular education courses). Every permissible combination is not found in this search. For instance, situations in which a teacher is required to have multiple teaching fields or multiple credentials do not appear.

Note that the general rule for elementary credentials (i.e., Kindergarten-Primary (KP), Kindergarten-Elementary (KE), Elementary (EL), Early Childhood (EC)) allows the teachers who hold these credentials to teach any course within the relevant grade range. These situations are not reflected within this search tool. An exception to this rule is for those initially hired on or after July 1, 2013, to teach physical education. These teachers must be licensed in PE and are included in this search tool.

  - If HQT IRN is reported as \*\*\*\*\*, or is not valid, then CALC TLC IRN will match the Location IRN from the Course Master (CN) Record

  - These courses will not negatively impact the LRC and can be reported, however, the row will remain as a critical
- Are there students being reported as enrolled in the course?
  - Check the dates to be sure they are aligned
    - Calendar start and end dates
      - Uses the most common calendar dates for the majority of students in the course
    - Course Master (CN) Record start and end dates
    - Staff Course (CU) Record start and end dates
    - Student Course (GN) Record enrollment start and end dates



### Not Properly Certified

No Current Credential or Incorrect Student Population

- Filter on TLC Result Code TL0006 (Informational)
- Staff not certified to teach this subject code or student population
  - Check certification to see if they can teach the subject code
  - Check the student population, is it correct?
  - Filter by that staff member to see all courses and student populations to verify
- Check the students who are enrolled in the course to verify that they align with the student population element
- Could be a career technical course that requires an override
  - Contact the Office of Career Tech

### Not Properly Certified – No Staff Course Record

### No Staff Course (CU) Record

- Filter on TLC Result Code TL00010 (Fatal)
- Teacher will not appear on the TLC Status Report
- Check Level 1 Validations for fatal or dependent errors that could cause the Staff Course (CU) Record to not be reported
- Check for State Staff IDs that contain lower case letters
- Check for missing CJ records from a contracted staff reporting relationship



# Quick Check

The TLC Status Report performs teacher certification checks using your EMIS data, as well as data from other LEAs, against the CORE database. Verify that your data is correct prior to the close of the Initial Staff and Course Collection.

- Are you reviewing the TLC Status **Report regularly?**
- Are you reporting data accurately to EMIS?
- Are you working with district staff to verify the data?



# Summary

- The TLC Status Report contains both data to verify and issues to correct
- Some issues can be corrected and some are simply stating the fact
- Work with district staff to verify that the data is both correct and complete
- "No errors" does not necessarily mean that your data is complete and accurate
